What are my Rights

Theme:

Art for Children Uganda (ACU) is a community based organisation that started in 2006. ACU uses creative means of working with children through art based education, life skill training, psychosocial support programs and art workshops for children and youth in prison. ACU promotes art as a tool for positive interpersonal relationships, creative expression, and improved scholastic achievement among children and youth in Northern Uganda.

Art for Children Uganda (ACU) has announced its first National Children's Painting Competition for 2012. The painting competition is part of ACU programme for children to lift their voices on what affects them using a creative expression using ART.

The theme for this year's competition "What are my Rights". Most children still do not know what their rights are and how they should enjoy their rights as well as how to maintain and protect their rights alongside their responsibilities. ACU is creating a platform for all children regardless of those with specific artistic talents to speak up and help sensitize people around Uganda and the world to promote child rights among children and communities. The Children can reach out to the world through art.

Art for Children Uganda is inviting children aged 6-17 years are for this competition. Children are invited to send original painting of their art work focus on the theme. This should depict your settings where you spend most of your time like school, homes, play grounds etc. Children can send their paintings with a brief description of the drawing not more than 100 words.

The competition entry deadline is September 31st 2012. The organizers encourage children from around Uganda to submit their paintings to Art for Children Uganda office Plot 8-10 Market Street, Junior Quarters, Adyel Division or P. O. SELECTION OF WINNERS

Winners will be selected through a fair and impartial selection process by the Selection Committee appointed by Art for Children Uganda. Winners will get the opportunity for their work to be displayed at the global level through our/partners websites. Winners shall be announced on 16th of November 2012. The selected finalists will be published on facebook for public voting. The award ceremony of prizes will take place during the Northern Uganda Children's Marathon 2012 in Lira.

All children who submitted a painting shall be awarded with certificates of participation and selected entries will also appear in the "Dwon Otino" Magazine and on our facebook page and website.

- 1. The competition is open to **ALL** children in Uganda below the age of 18 years (both notional and foreign, school going and out of school, all gender and children with disability)
- 2. There is no entry fee.
- 3. Paintings must be done on A4 or A3 papers.
- 4. Competitors are free to choose any means of materials, crayons, colored pencils, watercolors, oils, etc that they are interested in, or like most for their paintings/drawings/writings.
- 5. Painting should **NOT** be mounted or framed.
- 6. Each entry should be certified by the parent/guardian/teacher as the original, unaided work of the competitor. Entries should be an individual effort and **NOT** a combined work.
- 7. Every entry should carry the following information in English and in Block Letters, at the back of the painting/drawing or at the end of the written work:
 - Full Name
 - Gender (Boy or Girl)
 - Date of birth
 - Name of School or Home Address
 - District and Region
 - Full postal address
 - Contacts (telephone, emails, etc)
- 8. You can submit as more entries as you like but awards shall be given to only on painting.
- 9. No entry will be returned. The copyright of all entries will rest with Art for Children Uganda
- **10.** Entries scanned and sent by emails **NOT** accompanied by a hard copy will not be accepted.
- 11. A fully paid trip for the winners and their chaperone to the party for the handover of prizes on December 8th 2012
- 12. Do not include any words in the paintings. All descriptions **NOT** more than 100 words should be on a separate sheet of papers and should be attach together with the drawings.
- 13. For written description, entries in local language without **ENGLISH** Translations **will NOT be considered.** Description may be in form of poems, plays, short stories, essays, descriptive writing, and the like. Description should be **Hand** written
- 14. The last date for receipt of entries is September 31st 2012.

The theme "Creating a Peaceful Environment for Children through Sports" The event aims at promoting talents among children, creating harmony and socialization, unity, peace and reconciliation, psychosocial support, promoting and upholding children's rights. The event will also mark the launch of the Northern Uganda Children's Marathon and will also recognize and celebrates the achievements of various organizations/individuals who/that have made a significant mark in changing the lives and transforming Uganda's children.

Various activity shall take place during race and in post race party which includes; National Painting competition, Music Dance and Drama, Blood donation, Voluntary Counseling and Testing, Art exhibition, Business exhibition Expo trade fair, Fun Games and Sports, Face painting, Safe Male Circumcision and Reproductive Health Awareness etc.










UN Convention on the Rights of the Child



"Rights" are things every child should have or be able to do. All children have the same rights. These rights are listed in the UN Convention on the Rights of the Child. Almost every country has agreed to these rights. All the rights are connected to each other, and all are equally important. Sometimes, we have to think about rights in terms of what is the best for children in a situation, and what is critical to life and protection from harm. As you grow, you have more responsibility to make choices and exercise your rights.

If the laws of your country provide better pro-tection of your rights than the articles in this Convention, those laws should apply.

You have the right to know your rights! Adults should know about these rights and help you learn about them, too.

These articles explain how governments and international organizations like UNICEF will

work to ensure children are protected with



Everyone under 18 has these rights.

Article 2

All children have these rights, no matter who they are, where they live, what their parents do, what language they speak, what their religion is, whether they are a boy or girl, what their culture is, whether they have a disability, whether they are rich or poor. No child should be treated unfairly on any basis.

Article 3
All adults should do what is best for you. When adults make decisions, they should think about how their decisions will affect children.

The government has a responsibility to make sure your rights are protected. They must help your family to protect your rights and create an environment where you can grow and reach your potential

Article 5
Your family has the responsibility to help you learn to exercise your rights, and to ensure that your rights are protected.

Article 6

You have the right to be alive.

You have the right to a name, and this should be officially recognized by the government. You have the right to a nationality (to belong to a country).

Article 8

You have the right to an identity — an official record of who you are. No one should take thi away from you. Article 9

You have the right to live with your parent(s), unless it is bad for you. You have the right to live with a family who cares for you.

Article 10

If you live in a different country than your parents do, you have the right to be together in the same place.

You have the right to be protected from kidnap-

You have the right to give your opinion, and for adults to listen and take it seriously.

You have the right to find out things and share what you think with others, by talking, drawing, writing or in any other way unless it harms or offends other people.

You have the right to choose your own religion and beliefs. Your parents should help you decide what is right and wrong, and what is best for

Article 15 You have the right to choose your own friends

and join or set up groups, as long as it isn't harmful to others

You have the right to privacy.

Article 17

You have the right to get information that is important to your well-being, from radio, newspaper, books, computers and other sources. Adults should make sure that the information you are getting is not harmful, and help you find and understand the information you need.

Article 18 You have the right to be raised by your parent(s) if possible

Article 19
You have the right to be protected from being hurt and mistreated, in body or mind.

Article 20

You have the right to special care and help if you cannot live with your parents

Article 21 You have the right to care and protection if

you are adopted or in foster care Article 22

You have the right to special protection and help if you are a refugee (if you have been forced to leave your home and live in another country), as well as all the rights in this

Convention.

You have the right to special education and care if you have a disability, as well as all the rights in this Convention, so that you can live a

Article 24

You have the right to the best health care pos-sible, safe water to drink, nutritious food, a clean and safe environment, and information to help you stay well.

Article 25

If you live in care or in other situations away from home, you have the right to have these living arrangements looked at regularly to see if they are the most appropriate.

You have the right to help from the govern-ment if you are poor or in need.

Article 27

You have the right to food, clothing, a safe place to live and to have your basic needs met. You should not be disadvantaged so that you can't do many of the things other kids can do

Article 28

You have the right to a good quality education. You should be encouraged to go to school to the highest level you can.

Your education should help you use and devel-op your talents and abilities. It should also help you learn to live peacefully, protect the environment and respect other people.

Article 30

You have the right to practice your own culture, language and religion - or any you choose. Minority and indigenous groups need special protection of this right.

You have the right to play and rest.

You have the right to protection from work that harms you, and is bad for your health and edu-cation. If you work, you have the right to be safe and paid fairly.

Article 33

You have the right to protection from harmful drugs and from the drug trade. Article 34

You have the right to be free from sexual abuse Article 35No one is allowed to kidnap or sell Article 36

You have the right to protection from any kind of exploitation (being taken advantage of).

Article 37

you in a cruel or harmful way.

Article 38

You have the right to protection and freedom from war. Children under 15 cannot be forced to go into the army or take part in war.

You have the right to help if you've been hurt, neglected or badly treated.
